Request to verify quantity of requested carts and support.

Pricing should include 30 telemedicine carts with support plan.

Request to verify quantity of requested stethoscope peripherals.

Pricing should include 30 peripheral stethoscopes with standard support.

Request to verify provider-to-provider consult software integration requirements.

Pricing should include software to facilitate synchronous provider-to-provider consults. We are seeking a fully integrated product for Oracle Cerner facilities and acknowledge the importance of allowing for flexibility in the integration timeline to ensure a successful implementation. Workflow should include single sign on for providers.

Request to verify inclusion of scheduled and on-demand visits.

Pricing should include the provision for scheduled visits. The vendor should demonstrate the capability for on-demand scheduling to accommodate future scalability.

Request to verify inclusion of asynchronous heart failure program.

Pricing should encompass an asynchronous virtual platform tailored for providing telemonitoring and facilitating self-care management for patients diagnosed with heart failure.
